The Nominating Committee, chaired by President-Elect, Jeanne Curtis will prepare an electronic ballot for the open Officer position, to be presented to the membership for vote no less than 15 days prior to the annual meeting. The Nominating Committee will make selections for the other open Board positions and provide to the Board of Directors for approval prior to the final slate being presented to the membership during the annual business meeting.
